- <sup>1)</sup> Hourly rate, price per hour or part thereof. Payment shall be charged for at least one hour, and each hour commenced shall be charged as a full hour.
- <sup>2)</sup> If case processing is required, an hourly rate or part thereof shall be charged.
- <sup>3)</sup> NB: A fee of EUR 35 (DKK 260) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.
- <sup>4)</sup> Where several documents are issued together to the citizen, a total fee of DKK 310 shall be charged.
- <sup>6)</sup> Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 2.870 shall be charged for the first passport and DKK 1.230 or DKK 1.789 for subsequent passports.
- <sup>7)</sup> Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 4.100 shall be charged for the first passport and DKK 1.230 or DKK 1.789 for subsequent passports.
- <sup>8)</sup> The fee may increase to Euro 135 or Euro 180 if an implementing decision has been adopted in the EU according to visa code article 25a. Does not apply to children up to and including eleven years of age.
